**ADMINISTRATIVE ORDER NO. \_\_\_\_\_**

I, Michael J. Dunleavy, Governor of the State of Alaska, under the authority of Article III, Sections 1 and 24, of the Constitution of the State of Alaska, issue this order to establish a procedure that ensures that the State of Alaska honors the due process and equal protection guarantees of the Fifth and Fourteenth Amendments, by protecting the integrity of elections and voting by its citizens.

**BACKGROUND**

Increasing numbers of citizens have grown concerned about the integrity of voting within the State of Alaska as a result of the high-profile 2010 U.S. Senate election; numerous sworn statements of citizens who have observed illegal and fraudulent voting practices throughout the State; the use of antiquated Diebold (Accu-Vote) voting machines in most precincts; numerous discrepancies in precinct registries; numerous chain of custody issues including the use of private agencies, controlled by political activists, to provide ballot security and transportation; the ability of precinct officials to access, handle, and destroy excess ballots with no oversight or centralized accountability; broad discretion of voting officials to store ballots, transcribe ballots, destroy ballots, and to otherwise determine validity of votes with little to no oversight; the use of electronic means (optical scanning) for recounts; and the complete inability of citizens, or even candidates, to conduct or otherwise demand full hand counts of ballots in the event of questioned elections.

**PURPOSE**

This Order implements the protections of the Fifth and Fourteenth Amendments, ensuring the integrity of the vote in the State of Alaska, and restoring citizens' faith in the legitimacy of elections and elected officials.

**ORDER**

Under the authority of Article III, Sections 1 and 24, Constitution of the State of Alaska, I, Michael J. Dunleavy, Governor of the State of Alaska, order the following effective immediately:

1. Any poll watcher at any precinct, immediately upon the conclusion of voting hours of any election, may demand that the precinct vote totals for any candidate, initiative, referendum, and/or recall be validated by a hand count conducted by the election board and observed by any poll watcher. If there is a discrepancy between such hand count and the Accu-Vote precinct tabulator or any other electronic summary of precinct votes, then the hand count shall be transmitted by the election board to the regional elections office.
2. Immediately before the beginning of voting hours, the election board must comply with any poll watcher's demand to open and view the storage compartment of any Accu-Vote or other ballot counting machine.

3. Any poll watcher may use any recording device while conducting his or her review of the election process. However, such device may not be used to record any voter's ballot while said ballot is within the control of that voter.
4. All unused ballots, immediately upon the conclusion of voting hours of any election, shall be accounted for, reported by serial numbers, and returned to regional counting centers. Prior to the certification of any vote, any candidate standing for election in that region, or his or her designee, may review such unused ballots under the supervision of an election official.
5. Prior to the certification of any vote, no ballots shall be transported, secured, or stored by any private agency.
6. All ballots cast by absentee or early voting shall, immediately upon receipt by any election official, be stored in a transparent, secured container in full view of a video recording device, and livestreamed 24-hours per day to a publicly accessible Internet website maintained by the State of Alaska, until said ballots are removed for review and counting. All parties and candidates shall be notified at least 72-hours in advance of any such removal and counting of said ballots and shall have opportunity for sufficient poll-watchers to view such count. If the count is by Accu-Vote machine or other mechanical or electronic means, any poll-watcher may demand a hand count of such ballots.
7. If any election official creates a duplicate ballot from a facsimile ballot, electronic vote, damaged ballot, or for any other reason creates or changes any ballot, such action shall be completed in full view of a video recording device, and livestreamed to a publicly accessible Internet website maintained by the State of Alaska.
8. For any election recounts demanded by any candidate under law, election officials must conduct a hand count of all ballots if such candidate so requests.

#### **RESPONSIBILITY FOR IMPLEMENTATION**

The Lieutenant Governor, with assistance from the Department of Administration, is responsible for the implementation of this Order and shall provide monthly progress reports to the Office of the Governor that detail the steps taken to implement this Order. The frequency of those progress reports may be changed to be required more or less frequently, upon direction from the Governor.

#### **DURATION**

This Order takes effect immediately and remains in effect until it is modified or rescinded.

## 12/31/2020 Alaska Election Reform meeting notes

Suggested Edits/Additions by attendees to the Executive Order that Joe Miller prepared for Governor Michael Dunleavy to sign, for securing a manual hand count for 2020 Alaska Elections:

- Tom doesn't see in the draft where it demands-requires that all poll watchers must be present prior to the counting being initiated.
- Also didn't see anywhere that says upon a request by poll watchers that there is a discrepancy the counting must be stopped until it is agreed to.
- People want punitive actions, Penalty for indiscretions
- All ballot movement, transporting or counting shall be conducted by groups consisting of at least one person from each party represented on those ballots.
- No destruction of anything at polls
- No Aps used in voting
- No other electronic vote
- No Early vote
- Immediately void unused ballots. Only original ballots shall be counted, no duplications/recreations of any kind.
- Physically void ballots and keep every single one of them.
- Totals on thermal ppr to be split out and affixed to a 8x10 piece of paper and put in pouch.

### Other audience concerns/suggestions:

- Diebold voting machines with TS and TSX as identifiers are highly corruptible machines and we must not let them be disbursed in Alaska. No matter what
- Audience concerned about legalities of Alaskans registering to vote. Examples include aftermath of LeDoux vote.
- Alaskans need a person/telephone # to report problems to the day of our election-- who will answer the phone.
- Pat P is highly concerned about absentee voting and many people are concerned about people who have died on the voter rolls. We want an audit of all Alaskans on voter rolls and a revamp (Dept of Administration John Lehe & Scott Jordon are already hired for this type of work).
- Lovely Alaskan lady says, "Voter registration at DMB when they go to do business—foreigners & anybody can click PFD etc." New York State is allowing illegal immigrants to receive drivers licenses. They could move to AK and transfer to AK driver's license.
- Folks concerned about "ranked voting". No ranked voting. David Eastman said he would keep an eye on it. We need a local to take this one and keep up with David on it.

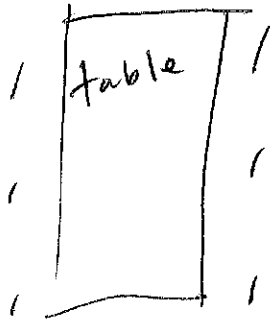

Joe. Talkeetna Holly called me this evening to tell me she had forwarded to you the six or so comments/recommendations of those in attendance at our meeting Friday. And she suggested I also send you my report of the corruption seven of us witnessed a few days after your 2014 US Senate election at the Wasilla elections office. I've told you what happened there in detail several times but I'll outline this here if it will help you with your efforts ongoing. We had an approved appointment with several days notice to observe, scrutinize, and verify the ballot counting. We were required to swear, sign, and have notarized a non-disclosure agreement, NDA. So my report here may already be legally "dead." The boss lady did not let us touch, count, record, photo, or even know how many ballots she had already processed with two incompetent temporary young girl hires. She said she knew we were coming of course and made certain to begin the counting process long before we arrived. We asked each other why we were there if we couldn't see all the ballots processed. Obviously, anything could have happened with the ballots with no witnesses in attendance. The two hires each had a counting machine and three piles of ballots: the uncounted pile, the counted machine accepted pile, and the machine rejected pile which the boss said could be as high as 10 to 12 percent of the total to be counted. When I saw one of the hires run a ballot and put it on the wrong pile, the boss agreed with me and reminded the hire that she was to place that type of ballot on the correct pile. I caught this, not the boss who was not keeping track of every ballot. I asked the boss to run 100 ballots through the machines and get the result reported from the machines. And then we would compare the machine's work with an actual, physical count of those ballots in order to verify the accuracy of the machines and her programming. She said "absolutely not." This really raised my suspect alert alarm. The boss told us that "I program the machines to count the ballots the way I want them counted." She told us that no one witnessed her programming the machines and she became miffed when we objected. When asked about hacking her programming and she agreed that a hack for \$12.50 could purchase an adapter that she uses and with knowledge about the working of the machines, could re-program the machine counting. When asked about the machine rejected ballots she said that she herself, with no witnesses, determined how each voter wanted to vote and then she would complete a new ballot and run it after destroying the original. She explained that Juneau always sends her more than 100% of ballots for registered voters should all of them vote. Because of Alaska's record of low voter participation, there are thousands of extra ballots in existence throughout the system during every election. When you put this availability together with the boss re-voting for voters with no witness verification, you lose the election integrity. And this loss is not recoverable when you add the fact that the boss told us she immediately destroys the ballots when she re-votes them. I told her that she just admitted to us that she violates the election rules that no ballot is to be destroyed until the Lt. Governor certifies the election. She said she knew that but she did it this way so that she could give an "accurate" report to election central with no remaining ballots in question. At this point Ron Johnson turned to me and said quietly that "Man, this is like Nazi Germany." The boss said "I heard that" and we found out later that she made an official complaint to Juneau on us. With me were Ron, Amy Walker, the Zimmermans, and a couple others which stayed there for about eight and a half hours which was a total loss as to our purpose of verifying integrity. The upside is that the availability for corruption in the actual, physical counting of ballots in Alaska was there exposed and personally witnessed. A couple times during our presence there the boss made it clear that she was not happy we were there especially when we indicated that her system could not possibly pass simple scrutiny for integrity. She asked "Don't you trust me?" more than once. She didn't seem to understand or accept that complete and accurate ballot counting was crucial to the results of elections. It was obvious that voter ballot complete integrity was of little concern to her especially when she freely admitted violating a longstanding election's rule, above. Flippant, inaccuracy, and being downright brazen are words descriptive of what we witnessed that sad day in 2014. Joe, it is easy to physically establish and maintain integrity in our ballot counting. It all comes down to required, documented public verification of every single ballot, whatever that takes. And of course this includes eliminating the machines and people currently in the system that are causing the problem, and punishing those who violate the rules. Jim.

Brian:

Below is the link to the election equipment we will be leasing. As I noted in our phone conversation we will be using ImageCast Precinct Tabulator (320-C) for the precincts and we will have ImageCast X (touchscreens) at two of our early/absentee sites, which are at the Borough Building and at the Division of Elections in Wasilla. The tabulator we will be using for absentee/question ballots is the ImageCast Central Kit.

In past elections we used the State's Accuvote machines at the precincts and to count the absentee/question ballots once they were canvassed. The new precinct equipment (ImageCast Precinct Tabulator) are slower at running the ballots, as the machine is tracking how each ballot has been counted, which would end up being much slower when counting the absentee/question ballots. So the absentee/question ballots will be counted through the ImageCast Central Kit.

The precinct tabulators will not be hooked up (internet) to transfer election results electronically. The election officials will run a paper copy of the results like normal and bring the machines back to the Borough Building. Once the election officials bring the precinct tabulators back to the Borough Building on election night, we will break the lock open and remove one of the Smart Cards to load into the

central tabulation system. The Canvass Board will still be verifying the election results as reported on election night. The outlying areas that don't bring the election equipment in until the next day, will call their results in on election night.

The Lieutenant Governor and the Division of Elections take transparency in elections very seriously.

As I mentioned, the division is currently conducting user acceptance testing. This is part of the formal contracting process. User acceptance testing at this point is nothing more than ensuring the equipment is what we ordered. Until user acceptance testing is completed, the state will not sign off on its receipt. It is the first step in a long process towards implementation.

I know the public will be very interested in seeing the equipment in person and receiving a demonstration. The division is not at the point in the project deployment to demonstrate the equipment. We do not have a mock election ready which would demonstrate how the ballots are scanned and tabulated. I will personally let you know when that happens and invite you to the Mat-Su Office to receive a demonstration of the equipment.

Until then, I am attaching brochures about the precinct equipment that will be used for the first time in the 2020 primary election.

## Voting Machines Security

### **The most secure form of voting**

The most secure form of voting is paper ballots. Any other solution adds a layer of complexity that requires additional security measures.

### **Which Voting machines are the State/Borough using?**

- Per the Director, Division of Elections, Gail Fenumiai, the State is using ImageCast [Precinct Tabulator 320-c, see McKechnie below] and ImageCast X optical scanning machines
- Per the Borough Clerk, Lonnie McKechnie, the Borough piggy-backs off the state and uses the ImageCast Precinct Tabulator (320-C) and the ImageCast X (touchscreens) at two of the early/absentee sites in Wasilla and the Division of Elections building in Wasilla. For the ImageCast Precinct models, there will be a central tabulating system that will accumulate votes.
- The AccuVote optical scanner was previously used.

### **Minimum Necessary Security Measures**

1. Hand Count option available upon request by either party through the clerk Two Person handling of memory cards at all times
2. Original memory card instructions (code) backed up and available for inspection by ether party upon request to clerk.
3. Video Cameras on any vault with tapes available for viewing upon request
4. Supervision of voting machines being distributed with two person installation of machines
5. No contract handling of machines/cards
6. Verification of code/software on machines available to any candidate upon request to clerk
7. Backups taken of all files on any central database before and after the election also available for verification by any candidate with final election results available on the second.
8. Paper ballot filled by voter available until election certified.
9. Tabulated results from voting machines need to be viewable by both parties upon request to clerk.

### **Importance of Hand Counting ballots run through an electronic voting machine**

The only way to effectively determine if a machine has been compromised or is malfunctioning is to perform a hand count of ballots. Machines are programmed to do the same thing each time. It is counter-intuitive to think that running ballots through a machine the second time will produce different results unless the machines instructions are faulty. A counting of ballots by hand will provide evidence for a malfunctioning or compromised machine. The ability to re-count ballots by hand has been blocked in the Mat-Su by the Clerk. I have personal experience on this one. Hand counting has also been blocked in other areas like Racine Wisconsin by a clerk even when enough evidence was provided to put the machine's count in question [see <https://www.youtube.com/watch?v=D1284ARxFag>]. The preventing of a hand count should not be an option with an electronic machine that could malfunction or be compromised.

Background: 12/1995 graduated from UWEC with MIS degree and began programming computers. Been in IT for almost 24 years. With approx. 5 years in more of a project management/supervisory capacity

I ran for Assembly District 1 twice losing by 171 votes the first time and 25 votes the second. I have no reason to believe there was voter fraud in my election although I was unable to challenge with a hand recount.

- Firmly against restricting shooting ranges

2 main types of voting machines

1. Scanner - paper trail, but recount often blocked

2. Touch Screen - no paper trail to recount

- Each requires a set of instructions to be loaded
  - One by Memory Card
  - One by Upload through internet or access point on the machine
- By the way the instructions are uploaded, they can be manipulated

- Results are sent via a paper tape with printed results upon finish of election. It's possible a central database could be used, but that would be worse in my opinion.

- Card can be exchanged or ports can be hacked within minutes
  - Youtube videos show AccuVote machines like the Borough's able to be hacked in minutes
  - FoxNews has a you-tube video showing the CA Deibold model hacked in minutes
- This info. Is not new, its been well known for many years

## **Opening Statement**

It is impossible to guarantee the validity or integrity of an election with electronic voting machines. With any electronic voting machine, you add additional, necessary measures of security above and beyond what is necessary for hand counting.

The only way to ensure a valid election is with paper ballots and hand counting available upon request from either party.

## **Basics - Electronic Voting Machines**

1. All electronic machines have a set of instructions (code) that is used to interpret and record machine/human interaction.
2. Code is stored on something transferrable/movable - usually a memory card/usb or transferred by internet, Testing Machine must be told what mode its in - testing, or election

## **Problems - Electronic voting machine**

1. Machine can crash
  1. no human interference, just a malfunction
  2. intentional sabotage - physical human interference
2. Virus can infect machine.

### **What is a virus and how does it work**

1. Intentional manipulation of code
2. Could be introduced at the origin, during testing, or anytime before the election.
3. Virus can spread during testing with memory card or usb or internet access
4. Votes can be manipulated through different instructions
  1. **Virus can crash machine.** Virus can erase computer files, necessary startup files, impact hardware and force a complete rebuild of a voting machine
  2. Virus Instructions **can run undetectable** while all else is functioning as normal
  3. A percentage of **votes can be transferred** from any one candidate to another, even one not running
  4. The **virus can run during the election cycle only** and 'disappear' during testing of the equipment before or after the election. All or any number of machines can be infected.
3. Central Database can be impacted

## **Readily Available Tools and Procedures**

1. Keys to break into machines are found on the internet.
2. Locks can be easily picked.
3. Instructions online
4. Most machines hacked in less than 7 minutes.
5. Seminars "Defcon" are held each year to try and hack machines
6. Princeton students evaluate machines

Thank you very much for being receptive to our feedback about Alaska election integrity in 2020. Private citizens in Southcentral Alaska watched the SOA 2020 training videos and are highly concerned. Please watch the videos yourself. They are well done by KTOO though the contents reveal that the SOA policy and procedures invites voter fraud.

### Observations:

1. Poll workers are allowed to help voters not only by spelling the candidates name for them, but actually writing the candidates name on the ballot for them. We do not remember this ever being allowed before. Can you please tell us when this rule was made and who made it?
2. Special needs voters protocol must be changed. If we understood the video presentation, special needs voters do not sign or even make a mark on the registry, and their ballots are kept in a separate compartment on the voting machine. Some of us have family with special needs and know that vanpools pick them up and bring them to the polls in Wasilla when they may not be clear about voting.
3. After the governor approved 2020 Hand Count double checks the accuracy of the new voting machines at each precinct this year, the vote count will be transmitted by modem over a phone line. The difference between now and ever before is the technology available that can threaten the accuracy of the information transferred over modem. Not to mention remote hacking, time-stamped virus for a day and good old fashioned electrical interference in the voting area.
4. People are highly concerned about the rule stating that any registered voter can vote (even if they do not speak english or native Alaskan language). Most Alaskans believe that it is critical to read, speak and understand our language in order to vote here. We need to change this. We are trying to protect Alaska.

Many of your concerns are covered and how we can deal with your concerns are dictated in State law. We have to follow statute and plan to do so to conduct the election. I am in the process of drafting and proposing a suite of bills next legislative session that specifically deal with election integrity.

Please see my responses below to the concerns you raised in your email. Thanks for contacting our office.

1. We want to know if our votes are transferred to District or any other place prior to sending them to Juneau?

On Election Night all unofficial results are sent to Juneau. Some voted ballots come directly to the Juneau Director's office (from outlying precincts). Some go to the regional offices (Mat-Su/Anchorage/Fairbanks/Juneau) and then are shipped to Juneau.

2. We want to poll watch and view the hand counts in the large population areas. May you please tell us the protocol to supervise the hand count this year?

Any recount or hand count is a responsibility of the division of elections. Recount procedures are outlined in statute and we have procedures in place also for the hand count verification that follows each election during part of the state review board process. You may be a poll observer if you are representing a candidate or party (AS 15.10.170).

3. May you please also tell us how to address and change the concerning observations mentioned above.

1. Poll workers are allowed to help voters not only by spelling the candidates name for them, but actually writing the candidates name on the ballot for them. We do not remember this ever being allowed before. Can you please tell us when this rule was made and who made it?

A voter is allowed to have assistance throughout any stage of the voting process by a person of their choice (AS 15.15.240) which was last changed by the Legislature in 2000.

2. Special needs voters protocol must be changed. If we understood the video presentation,

special needs voters do not sign or even make a mark on the registry, and their ballots are kept in a separate compartment on the voting machine. Some of us have family with special needs and know that vanpools pick them up and bring them to the polls in Wasilla when they may not be clear about voting.

The representative must complete their portion of the special needs envelop and sign before they are provided a ballot for a voter. The voter must sign the special needs envelope following voting as well as the representative. If the special needs ballots are returned to the precinct on Election Day, they are stored in either the emergency bin of the ballot box or a specific bag which has a lock on it. Any changes to this law (AS 15.20.072) will need to be made by the legislature.

Special needs voting is when a voter requests someone to bring them a ballot because due to a disability they are unable to go to the polls. Additionally, these votes are reviewed in the same manner as all absentee ballots before being opened and counted.

3. After the governor approved 2020 Hand Count double checks the accuracy of the new voting machines at each precinct this year, the vote count will be transmitted by modem over a phone line. The difference between now and ever before is the technology available that can threaten the accuracy of the information transferred over modem. Not to mention remote hacking, time-stamped virus for a day and good old fashioned electrical interference in the voting area.

Hand counts for accuracy will be conducted after the election to check for the accuracy of the voting machines, not at the precinct level. The machines have all been tested prior to deployment and are locked until the election date (AS 15.15.032). It has been a major challenge to get workers this year. They certainly don't want to work more than the 14 hours they are already required to serve. And the accuracy of their counts after such a long day would be challenged. And by statute we are not required to do so.

4. People are highly concerned about the rule stating that any registered voter can vote (even if they do not speak english or native Alaskan language). Most Alaskans believe that it is critical to read, speak and understand our language in order to vote here. We need to change this. We are trying to protect Alaska.

State law outlines the requirements for being a registered voter (AS 15.07.070). Any changes to this law will need to be made by the legislature. Our state law must also comply with Federal law as well (National Voter Registration Act of 1993). Additionally, although a 1998 ballot initiative passed in the State, it was struck down as unconstitutional in March of 2002. In 2014, the State added 19 native Alaskan languages as official languages of the state in addition to English. (AS 44.12.310)

5. Please note that the voting machines on the new 2020 video do not have the identification

numbers that you provided for our voting machines.

The voting machines used in the videos are the exact machines that will be used in the precincts on Election Day. We keep them secure. They have been tested and are programmed in-house and kept in a very secure area.

Thank you again for writing. To be clear, I am bound by State law in what can and cannot be done either before or after an election.

As you know, the Division and myself have been barraged by lawsuits ranging from issues arising from the two ballot initiatives to the decision to send out absentee applications to our residents over the age 65. There seems to be a good business in suing the State over any action or even any inaction.

I mention that in the context of your request for a hand count. As I previously wrote to you, the statute is very directive on recounts, when and how they can be conducted. I am sure you looked over the pages attached to the email. Under the law, there is no provision permitting a recount – hand count or otherwise, unless requested by the candidate or a group of 10 qualified registered voters. By not following the law, we open up this office and the Division of Elections to additional legal challenges to the elections process and the end result.

I am sure you would agree - election integrity begins with following the law. If an election, and any subsequent review or recount process is not conducted legally by following the statutes duly passed by the legislature there can be no basis to believe in the election's integrity. Granting exceptions to the law, even on a piecemeal basis erodes the foundation and further jeopardizes the faith Alaskans have in the process.

As I stated in an earlier email, under the law, if a recount is requested, I have directed the Division to make a hand count option available if asked for by the candidate or group of 10 qualified registered voters. There will be no additional charge for the hand count as the costs are outlined in statute.

I mentioned at both the Zoom meeting and the Republican Women's meeting that the Governor and I hope, if resources are available, to do a statewide hand count after the general election to confirm the accuracy of our vote tabulation machines. Even though we have no reason to believe they are not accurate.

I hope this helps clarify the situation.

Thanks again for all you do and for your interest in Alaska elections.

Holly,

First, let me say that in the process of certifying the Primary Election, the State Review Board found all the precinct counts were accurate – even the hand count for the randomly drawn precincts matched the initial vote totals. This was a good sign as we moved to the recount phase of the election.

I wanted to relay to you an update of the recounts that occurred after the Primary Election.

As you know, there were three races that qualified for an automatic recount per State Statute:

Senate District B – Coghill vs. Myers

House District 1 – Quist vs. Colbert

House District 23 – Henslee vs. Dougherty

The Division received requests for recounts in the SD B, and HD 23 races.

Additionally, John Cox submitted a request under AS 15.20.430 to recount the absentee ballots in HD 31.

Of note, he asked that they be hand counted which, as the Lt. Governor has pledged, was done.

I am happy to inform you that in two automatic recounts there were no errors in counting.

The votes counted both on election day and the absentee votes counted afterwards matched the vote totals during the recount.

I am equally happy to inform you that the hand count conducted on the absentees in HD 31 matched the initial vote totals as well.

We are pleased with the hard work of the thousands of people who helped conduct a successful Primary Election with our new machines.

As you know, the integrity of the election process and the confidence in the vote totals are the foundation of our democracy.

Our paper ballot-based system, assisted by the vote tabulators, continues to be the best way to

conduct an election in which everyone can have confidence.

Thank you for your email regarding the Alaska's election integrity.

The Division of Elections has released the following statement regarding Dominion Voting Systems:

**Statement on Voter Concern About Dominion Voting Systems**

The State of Alaska Division of Elections utilizes Dominion Voting Democracy Suite software and Image Cast precinct tabulators from vendor Dominion Voting, in 304 precincts that are not hand count precincts. The division performs all programming and testing of the system. We are aware of a communication issue between Dominion Voting equipment in Michigan and Michigan's election management system where all ballots were counted correctly but numbers reported from tabulator to the management system were incorrect and immediately detected and corrected. This was an isolated issue in one county in Michigan and there are no credible reports or evidence of fraud or widespread issues in Michigan or other states that use Dominion Voting equipment, including Alaska.

The division's systems and processes to tabulate and certify votes are protected by several safeguards that help ensure the accuracy of election results. The division performs all programming and our equipment is tested prior to each election by bi-partisan boards to ensure the election software is tabulating correctly. Errors can be identified and corrected because every tabulator prints a paper tape showing totals for every candidate and race. Because the division uses paper ballots, tapes can be compared to the ballots.

If an error is not noticed early on and quickly fixed, it would be caught and identified during the State Review Board (SRB) process. The bi-partisan SRB reviews precinct registers, ballot tabulation tapes, and summary sheets to verify election results accurately reported; reviews absentee voting accountability reports; reviews the absentee and questioned ballot registers that reflect the number of absentee and questioned ballots voted and counted to verify election results that were reported accurately; and finally, conducts a hand-count verification of one precinct per house district that accounts for at least 5% of ballots cast in that district. When this is all complete, the bi-partisan SRB certifies the election.

This same system was used in the August 2020 primary election. DOE conducted two recounts and the results came out the same as certified by the SRB. A third recount was conducted by hand and the results were the same as certified by the SRB. The integrity and accuracy of Alaska's election process is of utmost importance to the division. Our system of checks and balances has proved essential and effective to Alaska elections.

Thank you for your email regarding Election Integrity. The Lt. Governor reads every email and does appreciate you taking the time to reach out. The Lt. Governor is committed to overseeing fair and honest elections in the State of Alaska which includes ensuring one person has only one vote.

Recount applications can be accommodated under Alaska Statutes 15.20.430-.530 and a hand count can be requested. By law, the Division will conduct recounts in those districts where the race is very close, in addition to the usual random hand counts on precincts within each of the 40 house districts statewide. These counts will verify the accuracy of the tabulators just as they did in the primary election.

There are no credible reports or evidence of fraud regarding the Dominion Voting equipment in Alaska. Understanding that a state-wide hand count will be incredibly labor intensive and time-consuming, there may not be enough time to complete the task before certifying the election on or about November 24, 2020. We will continually assess the need for a statewide hand count as we progress through the election timeline as directed by state statute.

If you are not seeing anything on the news about election fraud, there are only 2 channels left that will cover it. Even FOX news has betrayed us. You can see the truth on OAN and Newsmax. There is a LOT there. George has hand counted their entire election and found the Dominion irregularities to be very random, but it exists.

To follow-up with more details... Many of you already know of the corruption, but I'm including some Alaskan details below too.

**First**, what you can do about it...

We need a **hand count** to discover Dominion manipulation of voter machines, and we need an **audit** to uncover absentee voter fraud.

If you would please write to the Governor and Lt Governor on Election Integrity in Alaska, that is what is needed to get anything done. A few of us have, but we are just a few and feel ignored. ### **More Details...**

#### **FIRST**

There needs to be an investigation of every single precinct to detect Dominion manipulation of votes -yes, Alaska has brand new Dominion voting machines that Lt Gov Meyer ordered and received this past July. Corruption can be discovered with a **hand count**. Dominion flipping of votes happens at random and the only way to discover it is to hand count every precinct. Big task, I know. But necessary, given the warnings nation wide. Frankly, the only way to prevent fraudulent vote counting is to **hand count with close-up video coverage of every precinct doing it, so voters can see for themselves all is above-board**. Secrecy breeds fraud and distrust.

#### **SECOND**

There is a serious problem with absentee ballots that swing our republican leads to democrat every year. Some problems are due to voter rolls that have not purged voters who moved away, and other problems exist due to a broken chain of command between the voter and DOE:

1. There are thousands of absentees sent to people who have moved out of state, and they vote. That is fine for military personnel (the vast majority are not), and nobody checks that at all. They primarily vote democrat (except for military). Unless they proactively remove their name from voter rolls, they remain long after they have moved to other states (we have researched a couple and discovered they purchased homes elsewhere, have no home here, and do not dare apply for a PFD). I have personally watched canvassing of absentees a couple of times. When asked the threshold for removing them from the voter rolls, there is tremendous resistance from DOE 'just in case they intend to return to Alaska some day.' These rolls need to be cleaned up! I believe this is the biggest voter fraud problem we have (other than hacking of the dominion computers).

An **audit** could discover which ones have moved away and their votes should not count.

2. Some receive extra ballots for everyone who has ever lived at their address. This happened to me when I lived in Anchorage (I got ballots for 2 previous roommates). This problem is huge in Anchorage, because they automatically send out ballots to everyone. The potential for fraud (especially since they decided not to require witness signatures this year) is far beyond TREMENDOUS. It's pretty much guaranteed.

**Mail-in voting should be illegal.** Fraud is guaranteed with this process.

3. The last time I observed canvassing I noticed that on their records some ballots appear to never have come back. That is pretty normal, but I did notice a bunch of them were never 'sent' or 'applied for' but were 'received' anyhow. What is with that? How can they be received when never asked for? That looks like ballot stuffing to me, frankly (but #4-5 below can account for some if it too). **Attached is a sample** Excel spread sheet illustrating what they are supposed to record. Note that they record the date of requests, the date it was mailed

out, and the date they received an absentee ballot back (this list was before any came back).

**An audit of the final list could expose potential voter fraud.**

4. Ballot harvesting by candidates who carry ballots when going door-to-door is an issue. NO voter should ever fill out a ballot and hand it back to the candidate. Any candidate who does this should be charged with voter fraud. Ask Rep LeDoux about that.

Voters can mail it in - but when DOE receives it, there is no way to really know who mailed it, the candidate or the voter. This can account for ballots who have no date asked for or received on the voter rolls, and is potential voter fraud because it breaks the chain of custody between voter and DOE.

**There should never be ballots received with no date requested or sent out.**

**Candidates should ONLY carry a 'request for absentee ballot' with them while going door-to-door so that voters communicate directly with DOE with a request for a ballot and when mailing a ballot in.**

5. There is a practice in Alaska in which nursing homes send a representative to collect a number of ballots, supposedly take them to the nursing homes for voters, and then the representative returns the ballots to the DOE. That breaks the chain of custody between the voter and DOE, thus is open to fraud. Voters should mail those in (but even that is subject to fraud as we have seen nation-wide). This can account for ballots who have no date asked for or received on the voter rolls. NO 'representative' should EVER turn in ballots for voters. There needs to be an alternate method of voting for these constituents.

LAST

There are cases where people vote in person and by absentee too. Canvassing ballots (cross-checking envelopes with voting rolls) should catch that and cancel out the absentee ballot, but unfortunately in many locations that process is not adequately supervised. Qualified observers say they are not permitted to view envelopes, and in some cases they are not allowed to view the process at all. In at least one district in Anchorage a candidate told me she was not permitted to observe the process at all, and had to leave. That should NEVER happen. The excuse was that it was too crowded, but the candidate should be given first priority over everyone else for observing.

PLEASE

Be aware that when candidates see irregularities they are hesitant to come forward for fear of being accused of 'sour grapes.' Please talk to your candidates who lost this time and encourage them to speak out if they saw anything irregular. Please encourage them to speak out until they get something done. You speak for them too, and encourage others in your district to speak for them too. If we don't make a LOT of noise nobody seems to listen or even care. If they will allow us to have a hand count and a thorough audit then we can discover irregularities and fix any problems with out voting process. If there are none, we can all celebrate that Alaska has Election Integrity.

**I hope you will scroll back up to the beginning and call or email the Lt Governor and Governor on these issues.**

Lt. Gov. Meyer:

We the undersigned are requesting a full audit by your office, under your authority, and hopefully with an independent observation team, to assuage concerns that Alaskans have over the integrity of the general election of 2020. This is not a new issue. There is a record of questionable elections in the past that have avoided scrutiny, specifically the 1978 Republican Primary, the 1982 attack on an electrical substation, and the write-in of Lisa Murkowski in 2010.

We list some of the concerns which, in light of the unfolding national events, we believe are not unreasonable to raise.

1. The inordinate erosion of leads held by Republican candidates for the state legislature that do not reflect the trends of election night, the August Primary nor the October Borough and Municipal elections.
2. The similar tendency towards the two ballot measures.
3. The results of "Judicial Retention", specifically for supreme court justice Susan Carney, who was specifically targeted for recall yet whose affirmative votes differ but little from those who were not a target of any non-retention campaign.
4. The inconsistent use of "Flair" or equivalent marking pens, as opposed to ball-point style in various areas throughout the state, which in the matter of other states, has resulted in warped results.
5. The decision by the Alaska Supreme Court to circumvent the requirement of Witnessed Signatures in mail-in ballots. What is the purpose of election laws if the whims of the court can negate them?
6. The need to purge the list of registered voters, reported by Judicial Watch at a nation-leading 111%.
7. But first and foremost, the shocking and dismaying revelation that Alaska is using the Dominion voting machines. If allegations currently being made hold true, the entire national and state election integrity is in question.

At this point, the answer "Trust us" will not hold wherever these machines are used. Notwithstanding, is there any reason why your office cannot require a publicly audited test of our voting machines, both before and after each election?

We are in uncharted waters at this juncture of Alaska and US History. It is our hope that confidence can be restored.

As the primary initiator of this email, I am willing to discuss this publicly --- on the air --- or privately and in-person, with perhaps one or two others in attendance --- BEFORE certification.

c. I asked "Is it true that for \$12.50 I can go to Best Buy or Radio Shack and buy an adaptor for my laptop and then <sup>be able to</sup> program the machine?" She said "yes and how did you know that?"

8c (CONT) I said that it was incumbent upon all of us as your "Boss" to make sure that you are properly/accurately doing the job we are paying you to do. This started her animated to us and our presence which resulted in her filing a complaint against us with Juneau. She said "I heard that!" when RON JOHNSON turned to me and quietly said "This is like NAZI GERMANY IN HERE!"

d- I asked her what she did with the 10-12% of the ballots rejected by the machines. She said that Juneau sends out 100 plus % of the ballots needed for a 100% vote of the registered voters and that she uses them to run them thru the machines. She said "I take the rejected ballots and decide how the persons wanted to vote then I fill in a new ballot and immediately shred the original ballot." I asked her who witnesses her doing this and she said "NO ONE DON'T YOU TRUST ME?" She admitted knowing that no ballots are to be destroyed until the LT. GOVERNOR certifies the election but explained that she did this so that there would be no mix up or need for hand counting.

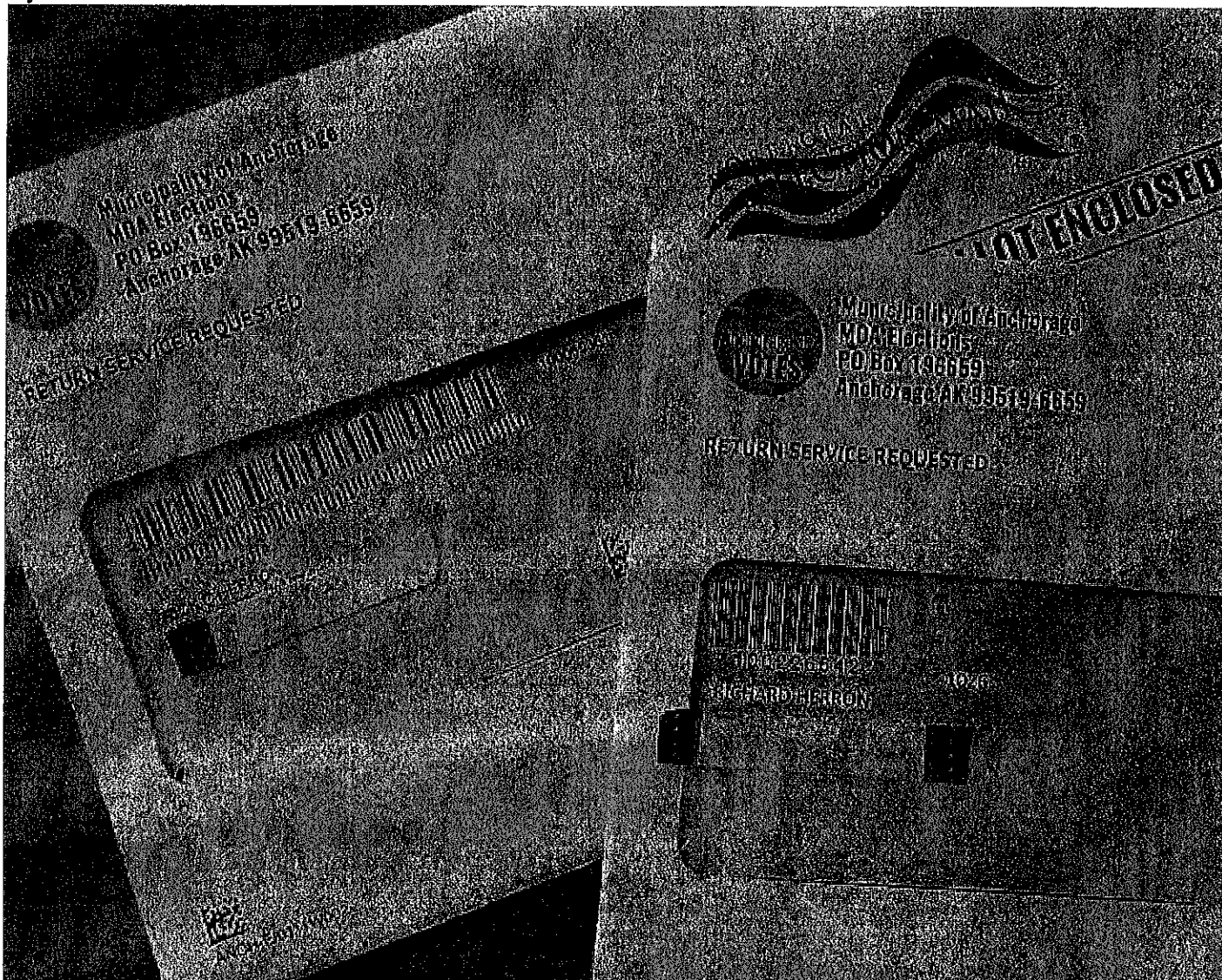
# State in the market for new election system

Will the State of Alaska become the next to switch to vote-by-mail? It's one of the options state election officials are considering as they look to replace the state's aging election equipment.

Election officials from around the state are meeting in Anchorage, listening to pitches from companies that are federally certified to sell election systems. Division of Elections Director Josie Bahnke said three different options are being considered, including vote-by-mail.

"One is a precinct-based system-- that's the current system that the state has right now," said Bahnke. "Secondly, a vote-by-mail system and thirdly, a hybrid of the two."

Bahnke said a hybrid system would be similar to what Anchorage has adopted that would include a place where people could vote in person as well as cast votes in the mail.

An Election Policy Working Group is expected to make a recommendation on what to purchase by the end of the year. Bahnke said the cost would likely run between \$2 and \$7 million and would be in place for a statewide election by 2022.

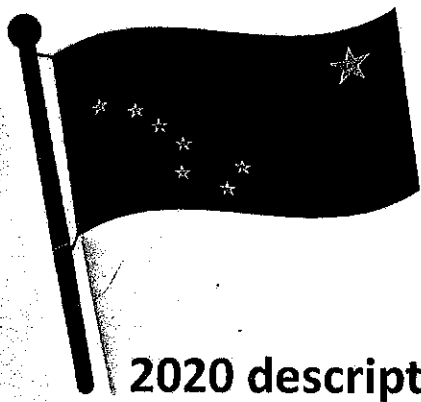
