

Resolution to Adopt Recall Legislation to Empower Alaskans

WHEREAS, Alaskans deserve elected representatives who effectively represent their interests and values; and

WHEREAS, concerns have been raised by Alaskans who feel their voices are not adequately heard or represented; and

WHEREAS, Alaskans aim to promote the principles and policies embraced by its members; and

I. Purpose and Scope
